

RUNSCORE END USER LICENSE AGREEMENT

THIS AGREEMENT is entered into as of the date ("Effective Date") of purchase on the RunScore site, RunScore.com, ("Runscore Site") by and between Race Roster North America Corp. (RUNTIME SOFTWARE), with office at 186 York Street, London, ON, N6A 1B5 ("LICENSOR") and the licensing entity ("LICENSEE") as described at the time of purchase.

WHEREAS, Licensee wishes to license software for the purpose of managing races and RUNTIME SOFTWARE desires to license this software to licensee.

NOW THEREFORE, the parties hereto agree as follows:

1. GRANT OF LICENSE

Subject to the terms and conditions of the Agreement, RUNTIME SOFTWARE grants to Licensee a limited, non-exclusive, non-transferable, revocable and non-sublicenseable license to use the RUNSCORE SOFTWARE ("License Programs") for the purpose of timing races. Licensee may use the Licensed Programs in executable format for its own use. Licensee may not, however, transfer or sublicense the Licensed Programs to any third party, in whole or in part, in any form.

2. CONSIDERATION TO RUNTIME SOFTWARE

- a) Licensee shall pay the cost as shown on the Runscore Site for software activation and first year support ("License Fee").
- b) License fees do not include any shipping, duties, bank fees, use, excise or similar taxes due. If Licensor is required to pay any such amounts, Licensee shall reimburse Licensor in full.
- c) Licensee shall ensure that the use of the Licensed Programs does not suggest RUNSCORE SOFTWARE promotes or endorses Licensee or any third party or the causes, ideas, web sites, products or services of Licensee or any third party.
- d) Licensee shall not use the Licensed Program in any manner or for any purpose that violates any law or regulation, any right of any person, including but not limited to intellectual property rights, rights of privacy, or rights of personality, or in any manner inconsistent with this Agreement.
- e) Licensee shall not sell, lease, share, transfer, or sublicense the License Programs or derive income from the use or provision of the Licensed Programs, whether for direct commercial or monetary gain or otherwise, without RUNTIME SOFTWARE's prior written permission.
- f) Licensee shall not use the Licensed Program in any way that unreasonably excessive, or that impacts the use and enjoyment of other licensed users of the RUNTIME SOFTWARE.

3. COPIES

Licensee may make copies of the Licensed Program in executable code form as necessary for use by Licensee and for backup or archive purposes. Licensee agrees to maintain records of the location and use of each copy, in whole or in part, of the Licensed Programs.

4. OWNERSHIP

The original and any copies of the Licensed Programs, made by Licensee, including translations, compilations, partial copies, modifications, and updates, are the property of RUNTIME SOFTWARE. Nothing in this Agreement shall operate to assign or transfer any Intellectual Property Rights from the Licensor to the Licensee.

5. PROPRIETARY RIGHTS

Licensee acknowledges and agrees that RUNTIME SOFTWARE owns exclusively the Licensed Programs, and that the Licensed Programs are proprietary information and constitute confidential trade secrets of great value. Licensee does not acquire any ownership interest in the Licensed Programs under this Agreement or any other rights thereto other than to use the Licensed Programs in accordance with the license granted, and subject to the terms, conditions and restrictions under the Agreement.

Licensee agrees not to provide or to otherwise make available in any form the Licensed Programs, or any portion thereof, to any person other than employees of Licensee without the prior written consent of RUNTIME SOFTWARE. Licensee further agrees not to reverse engineer the License Programs and to treat the Licensed Programs with at least the same degree of care with which Licensee treats its own confidential information and in no event with less care than is reasonably required to protect the confidentiality of the Licensed Programs.

If the Licensee is a race club, their Licensed Programs cannot be used by an individual or company to score and time a race for that individual's or company's profit.

6. TERM

The license granted hereunder shall continue unless and until terminated pursuant to Section 7 hereof and subject to Licensee's proper performance of its obligations hereunder.

7. TERMINATION

RUNTIME SOFTWARE may terminate this Agreement if Licensee is in default of any of the terms and conditions of this Agreement and fails to correct such default within ten (10) days after written notice thereof from RUNTIME SOFTWARE.

8. TERMINATION CERTIFICATE

In the event of termination, Licensee will immediately discontinue use of the Licensed Programs. Within one (1) month after termination of this Agreement, Licensee will furnish to RUNTIME SOFTWARE a certificate which certifies with respect to the Licensed Programs that, through its best effort and to the best of its knowledge, the original and all copies, in whole or in part and in any form, of each of the Licensed Programs have been destroyed. The provisions of Sections 4, 5, 8, 10, and 12 hereof shall survive any termination of this Agreement.

9. DELIVERY OF LICENSED PROGRAMS

The Licensed Programs can be downloaded from the RUNSCORE SITE for free. A prospective user can use the Licensed Programs for up to 30 days. During that time, the prospective user can pay the License Fee. Once paid, the user will be provided a License Name and License Key which, when applied to the Licensed Programs, will make the Licensed Programs fully usable.

Once the License Fee is paid, the user can download updates from the RUNSCORE SITE for up to one year. After a year, the program can be continued to be used but no updates can be applied until the "Update Fee" listed on the Runscore Site is paid. Upon payment of the Update Fee, the user can continue to download updates for a year and will receive support for a year.

10. WARRANTY DISCLAIMER

RUNTIME SOFTWARE LICENSES, and LICENSEE ACCEPTS, THE LICENSED PROGRAMS "AS IS." RUNTIME SOFTWARE PROVIDES NO WARRANTIES AS TO THE FUNCTION OR USE OF THE LICENSED PROGRAMS, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR PARTICULAR PURPOSE. THE ENTIRE RISK AS TO THE QUALITY AND PERFORMANCE OF THE LICENSED PROGRAM IS WITH LICENSEE. LICENSOR DOES NOT WARRANT THAT THE FUNCTIONS CONTAINED IN THE LICENSED PROGRAMS WILL MEET LICENSEE'S REQUIREMENTS OR THAT THE OPERATION OF THE LICENSED PROGRAMS WILL BE UNINTERRUPTED OR ERROR FREE.

11. PATENT AND COPYRIGHT INDEMNITY

RUNTIME SOFTWARE will defend at its own expense any action brought against Licensee to the extent it is based on a claim that the Licensed Programs used within the scope of the license granted hereunder infringe a United States patent, copyright or other proprietary right of a third party. RUNTIME SOFTWARE will pay any costs, damages or attorney fees finally awarded against Licensee in such action which are attributable to such claim, provided RUNTIME SOFTWARE is promptly notified in writing of such claim, may control the defense and/or settlement of such claim, and is provided with all requested assistance, information and authority. In the event that a Licensed Program becomes, or in RUNTIME SOFTWARE's opinion is likely to become, the subject of a claim of infringement of a United States patent, copyright or trade secret, RUNTIME SOFTWARE may at its option either secure Licensee's right to continue using the Licensed Programs, replace or modify the Licensed Programs to make them not infringing, or provide Licensee with a refund of the license fee less depreciation on a 5 (five) year, straight-line basis. RUNTIME SOFTWARE shall have no liability for any claim of patent, copyright or trade secret infringement based on the use of a Licensed Program in any form other than the original, unmodified form provided to Licensee or the use of a combination of the Licensed Programs with hardware, software or data not supplied by RUNTIME SOFTWARE where the used Licensed Programs alone in their original, unmodified form would not constitute an infringement. The

foregoing states Licensee's entire liability for infringement or claims of infringement of patents, copyrights or other intellectual property rights.

12. LIMITATION OF LIABILITY

RUNTIME SOFTWARE'S LIABILITY TO LICENSEE UNDER ANY PROVISIONS OF THIS AGREEMENT FOR DAMAGES FINALLY AWARDED SHALL BE LIMITED TO THE AMOUNTS ACTUALLY PAID HEREUNDER BY LICENSEE TO RUNTIME SOFTWARE. IN NO EVENT SHALL RUNTIME SOFTWARE BE LIABLE FOR INDIRECT, INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES, INCLUDING LOSS OF USE, LOSS OF PROFITS OR INTERRUPTION OF BUSINESS, HOWEVER CAUSED OR ON ANY THEORY OF LIABILITY.

13. NOTICES

All notices in connection with this Agreement shall be in writing and may be given by certified, registered, or first-class mail or personally delivered at the address set forth on the first page if to RunTime Software, LLC and delivered to the email address provided for Licensee if to Licensee. For purposes of this Agreement, a notice shall be deemed effective upon personal delivery to the party or if by mail five days after proper deposit in a mail box.

14. SUCCESSORS

This Agreement will be binding upon and will inure to the benefit of the parties hereto and their respective representatives, successors and assigns except as otherwise provided herein.

15. SEVERABILITY

In the event any provision of this Agreement is determined to be invalid or unenforceable, the remainder of this Agreement shall remain in force as if such provision were not a part.

16. GOVERNING LAW/FORUM

This Agreement shall be governed and interpreted by the laws of the Commonwealth of Massachusetts. Suffolk County shall be the appropriate venue and jurisdiction for the resolution of any disputes hereunder. Both parties hereby consent to such personal and exclusive jurisdiction.

17. NON-ASSIGNMENT

This Agreement and the licenses granted by it may not be assigned, sublicensed, or otherwise transferred by Licensee without the prior written consent of RUNTIME SOFTWARE.

18. EXPORT REGULATIONS

Licensee understands that RUNTIME SOFTWARE may be subject to regulation by agencies of the U.S. Government, including the U.S. Departments of Commerce and State, which prohibit export or diversion of certain technical products to certain countries. Licensee warrants that it will comply in all respect with all applicable export regulations. Licensee agrees to indemnify and hold RUNTIME SOFTWARE harmless from any loss, damages, liability or expenses incurred by RUNTIME SOFTWARE as a result of Licensee's failure to comply with any export regulations or restrictions.

19. ENTIRE AGREEMENT

This Agreement sets forth the entire understanding between the parties with respect to the subject matter hereof, and merges and supersedes all prior agreements, discussions and understandings, express or implied, concerning such matters. This Agreement shall take precedence over any additional or conflicting terms which are not part of this agreement.

In addition, each party represents and warrants that it has the necessary and full right, power and authority to enter into the agreement and to perform its obligations hereunder.
